Data privacy notice on personal data processing as part of the activities taken by the Polish Association of Listed Companies

As per article 13, item 1 and 2 of the Regulation 2016/679 of the Parliament and of the Council (EU) of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (general data protection regulation), (hereinafter: GDPR), we hereby inform that:

1. The controller of your personal data is the Polish Association of Listed Companies with its registered office at Nowy Świat 35/5a, Warsaw (00-029), hereinafter: SEG. You can contact SEG by e-mail: rodo@seg.org.pl or in writing to the address specified above.
2. Your personal data will be processed for the purpose of sending:
 - marketing material and information on available services and projects led and co-led by SEG,
 - SEG newsletter,
 - Information about events organized by SEG, special offers for SEG members and other information about operations of listed companies.
3. The legal basis for data processing is Article 6.1.a of GDPR.
4. Your personal data will be retained for a period necessary to fulfill the purpose discussed under item 2 above.
5. Your personal data will not be transferred to other parties, including parties in third countries or international organizations, except for public authorities for whom there is a legal basis for such data transfers.
6. Your personal data will not be used to make automated individual decisions, including profiling.
7. You have the right to demand access to your personal data, to correct them and to remove them after the periods referred to under item 4, or to restrict their processing as well as the right to transfer your data.
8. You have the right to withdraw your consent to processing your data at any time, and the withdrawal of consent will not affect the lawfulness of data processing before the consent withdrawal.
9. To exercise your rights discussed under items 7 and 8 you should contact the data controller in writing to the address of the SEG registered office (with the annotation "zgoda RODO"/"GDPR consent") or via email: rodo@seg.org.pl.
10. You have the right to submit a complaint to the regulatory authority: the President of the Personal Data Protection Office, if you think that processing your personal data breaches the law.
11. Providing your personal data is voluntary but it is necessary to fulfill the purpose discussed under item 2.
